**RESOLUTION COMMENDING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY; PNP, SK3 AND BARANGAY ELECTIVE AND APPOINTIVE OFFICIALS IN ITS COLLABORATIVE ACT RELATIVE TO ROAD CLEARING OPERATIONS WHICH GARNERED 99.89 COMPLIANCE AS PER RECENTLY CONCLUDED ASSESSMENT CONDUCTED BY THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG).**

**WHEREAS**, in line with the Presidential Directive during the 2019 State of the Nation Address of His Excellency Rodrigo Roa Duterte, all local government units are directed to exercise their powers essential to reclaim public roads which are being utilized for private ends and in the process, rid them of illegal structures and constructions;

**WHEREAS**, in compliance thereof, the Department of the Interior and Local Government (DILG) issued series of memorandum circulars addressed to local government units setting deadlines and reiterating the aforementioned directive of the president;

**WHEREAS**, for this purpose, the City Government of Sorsogon was scheduled for assessment last February 24, 2021 spearheaded by the Department of Interior and Local Government (DILG) and Sorsogon City garnered 99.89 Total Score for all components as reflected in the Road Clearing Validation Form for LGU's Performing Full Implementation pursuant to DILG Memorandum Circular No. 2020-27 and 2020-145;

**WHEREAS**, the present administration's strong political will and resilient management through corroboration among our leaders which garnered record high percentage per herein assessment deserves commendation and admiration;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution commending the Hon. Ma. Ester E.
