RESOLUTION AUTHORIZING THE MEMBERS OF THE  $7^{TH}$  CITY COUNCIL TO TEMPORARILY PRESIDE DURING REGULAR/SPECIAL SESSION OF THE  $7^{TH}$  CITY COUNCIL ON ROUND ROBIN BASIS.

**WHEREAS**, among the issues raised by the Hon. Franco Eric O. Ravanilla during the March 01, 2021 Regular Session is his proposal to give members of the 7<sup>th</sup> City Council the chance to experience being the temporary presiding officer during regular/special session;

WHEREAS, the said proposal is anchored on the principle that each member of the Sangguniang Panlungsod should have the capacity to preside before regular and special session of the Sanggunian aside from being the presiding officer on their respective committees;

**WHEREAS,** for purposes of this resolution, the City Vice Mayor being the regular presiding officer may opt to preside anytime during their scheduled regular/special session;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the members of the 7<sup>th</sup> City Council to Temporarily Preside during Regular/Special Session of the 7<sup>th</sup> City Council on Round Robin Basis;
