RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT (DOH-CHD) – BICOL RELATIVE TO THE INTEGRATED CLINIC INFORMATION SYSTEM (iClinicSys)

**WHEREAS,** the Department of Health by virtue of its mandate, hold the over-all technical authority in health with three major roles of leadership and regulator in health, enabler and capacity builder and administrator of special health services;

**WHEREAS,** RA 7160 otherwise known as the Local Government Code of 1991 mandates the devolution of the delivery of health services and facilitates as one of the basic functions and responsibilities of all LGUs at all levels;

**WHEREAS,** RA 3573 otherwise known as "Law on Reporting Communicable Diseases" requires all individuals and health facilities to report notifiable diseases to local and national health authorities;

WHEREAS, the Integrated Clinic Information System (iClinicSys) is a software provided for free from the Department of Health Center for Health Development (DOH-CHD) – Bicol which can be used for the establishment and operation of an electronic medical record and health information system intended for the generation of data for local use and submission to the DOH and PhilHealth;

NOW THEREFORE, on incidental motion of Hon. Mary Ellen D. Jamisola duly seconded by the Hon. Hilario D. Dioneda, resolve as it is hereby resolved to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, to enter into a Memorandum of Agreement (MOA) with the Department of Health Center for Health Development (DOH-CHD) – Bicol relative to the Integrated Clinic Information System (iClinicSys).
