**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, TO DONATE A PARCEL OF LAND CONSISTING AN AREA OF MORE OR LESS ONE THOUSAND SQUARE METERS (1,000 SQ. M.) SITUATED AT DIVERSION ROAD, BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY TO THE PHILIPPINE NATIONAL POLICE (PNP)**

**WHEREAS**, the Office of the City Mayor, on its letter dated February 26, 2021 (Transmittal No. 12, series of 2021) addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod, furnished the 7<sup>th</sup> City Council a copy of the perfected Deed of Donation by and between the city government of Sorsogon and the Philippine National Police (PNP) covering a parcel of land consisting an area of one thousand square meters (1,000 sq. m.) situated at Diversion Road, Barangay Cabid-an, East District, Sorsogon City;

**WHEREAS**, the said parcel of land is now being occupied by the PNP as their central office in the city of Sorsogon where they facilitate all pertinent transactions relative to security, peace and order which redounds to the benefits of the community;

**WHEREAS**, behind the said station is an area which remains in the possession of the city government and beside the property owned by the Sorsogon City Water District;

**WHEREAS**, considering that the city government has no further need of the subject area and that the PNP is requesting for an additional space for police related activities, the city government found it just and proper to donate the said parcel of land to the latter;

**NOW THEREFORE**, on incidental motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to pass a resolution authorizing the Hon. Ma. Ester E. Hamor, City Mayor, to donate a parcel of land consisting an area of more or less One Thousand Square Meters (1,000 sq. m.) situated at Diversion Road, Barangay Cabid-an, East District, Sorsogon City to the Philippine National Police (PNP).
