RESOLUTION DECLARING VALID BARANGAY ORDINANCE (RESOLUTION NO. 02, SERIES OF 2021) FROM THE BARANGAY COUNCIL OF BARANGAY SULUCAN, EAST DISTRICT, SORSOGON CITY ENTITLED "A RESOLUTION ADOPTING AND AMENDING THE BARANGAY TAX ORDINANCE NO. 01, SERIES OF 2012 OTHERWISE KNOWN AS THE NEW REVENUE TAX CODE OF BARANGAY SULUCAN, EAST DISTRICT, SORSOGON CITY"

WHEREAS, Barangay Ordinance (Resolution No. 02, Series of 2021) from the Barangay Council of Barangay Sulucan, East District, Sorsogon City was among the items deliberated upon by the 7th City Council during the March 2, 2021 Regular Session;

WHEREAS, cursory reading of the submitted barangay tax ordinance reveals that the said barangay tax ordinance is within the ambits of the powers conferred to the barangay council by virtue of Section 152 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

WHEREAS, the Sangguniang Panlungsod finds the barangay tax ordinance intra vires as mandated by the Local Government Code of 1991;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution declaring valid Barangay Tax Ordinance (Resolution No. 02, Series of 2021) from the Barangay Council of Barangay Sulucan, East District, Sorsogon City entitled "A Resolution Adopting and Amending the Barangay Tax Ordinance No. 01, Series of 2012 otherwise known as the New Revenue Tax Code of Barangay Sulucan, East District, Sorsogon City";

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Rebecca D.
