## Resolution No. 098, Series of 2021

RESOLUTION AUTHORIZING THE CONTINUANCE OF INVENTORY BY THE CITY TRICYCLE FRANCHISING REGULATORY OFFICE AND BUSINESS PERMIT AND LICENSING SECTION FOR THE PERIOD MARCH 22-26, 2021 ONLY FOR PURPOSES OF ACCOMMODATING TRICYCLE FRANCHISE HOLDERS WHO FAILED TO SUBMIT AND APPEAR BEFORE THE SANGGUNIANG PANLUNGSOD DURING THE SCHEDULED INVENTORY CONDUCTED LAST FEBRUARY 15, 2021 TO MARCH 08, 2021.

**WHEREAS,** Section 458 (3) (vii) of Republic Act 7160 otherwise known as the Local Government Code of 1991 provides that;

Section 458 (3) (vii)- Subject to the Guidelines prescribed by the Department of Transportation, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the city.

**WHEREAS**, in consonance thereof, the City Government of Sorsogon through the Sangguniang Panlungsod have issued tricycle franchise plying authorized tricycle routes;

WHEREAS, for purposes of updating, monitoring and recording, an inventory of existing tricycle franchise issued by the Sangguniang Panlungsod was conducted last February 15, 2021 to March 08, 2021 wherein scheduling and systematic inventory was conducted assisted by the City Tricycle Franchising Regulatory Office;

WHEREAS, after the last day of scheduled inventory, records from the City Tricycle Regulatory Office reveals that there are Seven Hundred Eighty One (781) franchise holders who failed to submit and appear before the Sangguniang Panlungsod through the City Tricycle Franchising Regulatory Office for purposes of physical inventory;

**WHEREAS**, among the provisions stipulated in the Notarized Application for Renewal of Franchise or Application for New Franchise is that the supposed Tricycle Franchise Holder is financially capable to operate and maintain a tricycle unit for purposes of protecting the interest of the riding public;

WHEREAS, for purposes of this resolution, aforementioned extension date of Inventory covering the period March 22-26 2021 shall in no case be further extended and failure on the part of the tricycle franchise holder to submit and appear before the Sangguniang Panlungsod through the City Tricycle Franchising Regulatory Office shall be a valid ground for revocation of the tricycle franchise;

**WHEREAS**, the preceding statement is anchored on the ground that franchise holder failed to adhere to the conditions stated in the Notarized Application for Renewal of Franchise or Application for New Franchise;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution authorizing the Continuance of Inventory by the City Tricycle Franchising Regulatory Office and Business Permit and Licensing Section for the Period March 22-26, 2021 only for Purposes of Accommodating Tricycle Franchise Holders Who Failed to Submit and Appear Before the Sangguniang Panlungsod during the Scheduled Inventory conducted last February 15, 2021 to March 08, 2021;

**NOW THEREFORE**, on motion **City Councilor Nestor J. Baldon** duly seconded by the body, resolve as it is hereby resolved to authorize the continuance of Inventory by the City Tricycle Franchising Regulatory Office and Business Permit and Licensing Section for the Period March 22-26, 2021 only for Purposes of Accommodating Tricycle Franchise Holders Who Failed to Submit and Appear Before the Sangguniang Panlungsod during the Scheduled Inventory conducted last February 15, 2021 to March 08, 2021.

**RESOLVED FURTHER**, that copies of this resolution be furnished to all concern for their information, guidance and appropriate action.
