**RESOLUTION ADOPTING EXECUTIVE ORDER NO. 11-2021 ISSUED BY THE OFFICE
OF THE PROVINCIAL GOVERNOR, MODIFYING COVID 19 GUIDELINES IN
CONSONANCE WITH IATF RESOLUTION NO. 101, SERIES OF 2021 AND FOR
OTHER PURPOSES**

WHEREAS, IATF Resolution No. 76, Series of 2020, dated 02 October 2020, approved the recommendation of the Economic Development Cluster on further reopening of public transportation in such manner that is sufficient and safe to the public, following health experts guidance on minimum health standards;

WHEREAS, Executive Order No. 78-2020 issued on 09 December 2020, provided guidelines for the prevention, detection, isolation and reintegration strategies for Covid 19 in the province of Sorsogon;

WHEREAS, IATF Resolution No. 101, Series of 2021 issued 04 February 2021 (amended by Resolution No. 98-A) provided guidelines for the government officials/personnel of National Government Agencies and their attached agencies for their unimpeded travel to their place of destination in the performance of critical government services;

WHEREAS, Executive Order No. 11-2021 provides Intra-Regional travel within the Bicol Region to and from the Province of Sorsogon via public transport and its governing policies, rules and regulations;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Jo Abegail C. Dioneda**, resolve as it is hereby resolved to pass a resolution adopting Executive Order No. 11-2021 issued by the Office of the Provincial Governor, modifying Covid 19 guidelines in consonance with IATF Resolution No. 101, Series of 2021 and for other purposes.
