**RESOLUTION AUTHORIZING THE CONDUCT OF REGULAR SESSION OF THE 7<sup>TH</sup> CITY COUNCIL AT THE BACON OLD MUNICIPAL HALL AT BACON DISTRICT EVERY TUESDAY OF THE FOURTH (4<sup>TH</sup>) WEEK OF THE MONTH**

**WHEREAS**, the historical Bacon Old Municipal Hall/Building has been renovated, restored and refurbished by the city government with duly furnished office equipment and facilities to include office space for the City Mayor, City Vice Mayor, four City Councilors of Bacon District, SP Secretary, Liga ng mga Barangay and offices of the frontline services of the Executive Department;

**WHEREAS**, similar to any deliberative body, the Sangguniang Panlungsod of the City of Sorsogon shall successfully and expeditiously conduct its proceedings thru adherence to a set of rules that serves as a guide in its effective and orderly discussion which in effect will protect and preserve the dignity of this body;

**WHEREAS**, pursuant to Section 50 of the Local Government Code of 1991, the Sangguniang Panlungsod of the City of Sorsogon is authorized to adopt its own Internal Rules of Procedure for the effective and proper discharge of its legislative functions;

**WHEREAS**, under Section 1, Rule VI (Session and Quorum) of the Internal Rules for Parliamentary and Administrative Procedures of the 7<sup>th</sup> City Council under Resolution No. 001, Series of 2019, approved and adopted on July 30, 2021, the Sangguniang Panlungsod shall hold its regular sessions every Tuesday of the week at 2:00 o'clock in the afternoon at the Sangguniang Panlungsod Session Hall, Legislative Building, City Hall Compound, Barangay Cabid-an, East District, Sorsogon City, thus, this measure shall be construed as an exemption and amendment thereto;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon** duly seconded by the **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to pass a resolution authorizing the conduct of regular session of the 7<sup>th</sup> City Council at the Bacon Old Municipal Hall at Bacon District every Tuesday of the fourth (4<sup>th</sup>) week of the month.
