**RESOLUTION IDENTIFYING AND DECLARING THE 3,000 SQ. M. OF THE 13,887 SQ. M. OF THE CITY GOVERNMENT PROPERTY WITH PROPERTY IDENTIFICATION NO. 189-03-0005-003-11, TD NO. 2011-03-0005-00121 AND SURVEY NO. 96 LOCATED AT BARANGAY BUENAVISTA, WEST DISTRICT IS INTENDED FOR THE CONSTRUCTION OF EVACUATION CENTER**

**WHEREAS**, being frequently visited by typhoon and with the numbers of households exposed to the hazards it brings, the city government of Sorsogon doubles its efforts in evacuating the most vulnerable members of the society during occurrence of such events;

**WHEREAS,** not all barangays in the city of Sorsogon have the evacuation center to accommodate their respective residents and despite of the city government efforts to provide every barangay in the city, the same could not be achieved due to financial constraints;

**WHEREAS,** the city government seek financial assistance to various national agencies specially the Department of Public Works and Highways;

**WHEREAS,** in response thereto, the Department of Public Works and Highways required a resolution of the Sangguniang Panlungsod declaring thereat that the city government has a parcel of lot available and intended for the evacuation center;

**NOW THEREFORE,** on incidental motion of **Hon. Nestor J. Baldon** duly seconded by the **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to pass a resolution identifying and declaring the 3,000 sq. m. of the 13,887 sq. m. of the city government property with Property Identification No. 189-03-0005-003-11, TD No. 2011-03-0005-00121 and Survey No. 96 located at Barangay Buenavista, West District is intended for the construction of evacuation center.
