RESOLUTION FAVORABLE ENDORSING THE REQUEST FOR FUNDING INTENDED FOR THE PURCHASE OF THREE (3) UNITS RESCUE VEHICLE AND THREE (3) UNITS OF AMBULANCE OF THE CITY GOVERNMENT OF SORSOGON TO THE DEPARTMENT OF BUDGET & MANAGEMENT (DBM)

**WHEREAS,** among the items deliberated during the March 23, 2021 Regular Session of the  $7^{\text{th}}$  City Council was the letter from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda and the Honorable Members of the Sangguniang Panlungsod thru Mr. Rovan Domasian, SP Secretary requesting for a favorable endorsement of

the request for funding intended for the purchase of three (3) units rescue vehicle and three (3) units of ambulance to the Department of Budget & Management (DBM);

**WHEREAS**, three units of rescue vehicle would cost Nine Million Nine Hundred Thousand (P9,900,000.00) and three units of Ambulance would cost Eight Million Four Hundred Thousand (P8,400,000.00), respectively;

**WHEREAS**, this is in view of our commitment to ensure an effective and efficient emergency response by assuring the proactive availability of vehicles that can be used in times of need;

**WHEREAS,** the City Government of Sorsogon will be able to address the needs of the community in terms of peace and order, disaster preparedness, social services and health.

**NOW THEREFORE,** on motion of the **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to favorable endorse the request for funding intended for the purchase of three (3) units rescue vehicle and three (3) units of ambulance of the City Government of Sorsogon to the Department of Budget & Management (DBM)
