**RESOLUTION** APPROVING THE HEREUNDER STATED ANNUAL/SUPPLEMENTAL BUDGETS OF VARIOUS BARANGAYS OF BACON DISTRICT IN THE CITY OF SORSOGON

4. The implementation of Mid-year Bonus, must be in accordance with Budget Circular No. 2017-2 dated May 8, 2017 and must be subject to the Personal Services limitation

budgets pursuant to Section 325 (a) and 331 (b) of R.A No. 7160.

Adjustment in the appropriation should be made in case of overdraft or imminence

thereof before the end of the fiscal year.

that is specifically prohibited by or inconsistent with the provision of law
