**RESOLUTION CONCURRING THE APPOINTMENT OF MR. HENRY C. GUEMO AS CITY GOVERNMENT DEPARTMENT HEAD I (PESO MANAGER) OF THE LOCAL GOVERNMENT UNIT OF SORSOGON CITY**

**WHEREAS**, as provided under Section 454 (d), RA 7160, heads of the departments shall be appointed by the City Mayor with the concurrence of the majority of all the members of the Sangguniang Panlungsod subject to civil service laws, rules and regulations wherein the Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise, the same shall be deemed confirmed;

**WHEREAS**, RA 7160 also mandated the position of PESO Manager (CGDH I) as City Official among other positions;

**WHEREAS**, upon submission of the appointment documents, presence of the appointee in plenary and after due deliberation on the matter, the 7<sup>th</sup> City Council deemed it necessary to pass a resolution concurring the appointment of **MR. HENRY C. GUEMO AS CITY GOVERNMENT DEPARTMENT HEAD I (PESO MANAGER)**;
