RESOLUTION RESTPECTFULLY REQUESTING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO PUT UP AND ESTABLISH A SATELLITE AND EXTENSION SERVICE CENTER OF THE CITY PHARMACY AT THE BACON OLD MUNICIPAL BUILDING AND IN WEST DISTRICT, ALL OF SORSOGON CITY

WHEREAS, it is a declared policy and objective of City Ordinance No. 03, Series of 2016, otherwise known as the "SORSOGON CITY PHARMACY ORDINANCE OF 2016" to make public health care in terms of basic medicine available to qualified indigent residents of barangays in the City of Sorsogon;

WHEREAS, it is glaring verity that many indigent residents in this City desperately beg and solicit amounts for the purchase of their medicines or prescription for their ailing family member, availability of the said documents must be distributed conveniently to the three (3) districts of the city of Sorsogon;

WHEREAS, there are numerous requests from the residents of Bacon and West Districts, specially the senior citizens and residents from far flung barangays in the districts to establish a satellite and extension service center in the Bacon and West Districts so that they can conveniently and expeditiously avail the services of the city pharmacy;

WHEREAS, it was observe that the present location of the City Pharmacy at Barangay Talisay, though belongs to West District, the majority of its clients were came from the East District, hence, Bacon and West Districts should have similar equal position;

WHEREAS, foregoing premises considered, it is deemed, just, proper and necessary to put up and establish a satellite and extension center of the city pharmacy at the Bacon Old Municipal Building and in West District;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Mark Eric C. Dioneda** duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to respectfully request Hon. Ma. Ester E. Hamor, City Mayor to put up and establish a satellite and extension service center of the city pharmacy at the Bacon Old Municipal Building and in West District, all of Sorsogon City.
