RESOLUTION ENJOINING ALL BARANGAY SENIOR CITIZENS ASSOCIATIONS, FEDERATION OF SENIOR CITIZENS AND OFFICE OF THE SENIOR CITIZENS AFFAIRS TO ACTIVELY PARTICIPATE AMONG THEIR PEERS THE WIDEST INFORMATION AND DISSEMINATION CAMPAIGN IN RELATION TO MINIMUM HEALTH PROTOCOLS IMPOSED BY THE INTER AGENCY TASK FORCE FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES (IATF-MEID)

WHEREAS, as of April 3, 2021, the Province of Sorsogon has recorded thirty (30) COVID 19 cases twenty four of which comes from the City of Sorsogon;

WHEREAS, said report is the highest recorded COVID 19 cases in Sorsogon City in a single day since day one;

WHEREAS, in view of this alarming incidence, the senior citizens, being one of the most vulnerable sector of our society needs to be protected and informed in order to safeguard their health against COVID 19 Pandemic;

WHEREAS, this gesture of the 7th City Council is an illustration of our tradition of protecting and taking care of our elders from harm and danger to include their health vulnerability against unforgiving health risk of COVID 19 Pandemic;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution enjoining all Barangay Senior Citizens Associations, Federation of Senior Citizens and Office of the Senior Citizens Affairs to actively participate among their peers the widest information and dissemination campaign in relation to minimum health protocols imposed by the Inter Agency Task Force For the Management of Emerging Infectious Diseases (IATF-MEID);
