**RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A CONTRACT OF SALE WITH THE FORTY (40) BENEFICIARIES OF THE HOUSING LOT PROJECT AT BLISS SITE, BARANGAY MACABOG, WEST DISTRICT, SORSOGON CITY**

**WHEREAS**, the 5<sup>th</sup> City Council has approved Resolution No. 279, Series of 2013 authorizing the then City Mayor Hon. Sally A. Lee to enter into a contract of sale with the beneficiaries of the housing lot project at Bliss Site, Barangay Macabog, West District, Sorsogon City;

**WHEREAS**, the former Municipality of Sorsogon has 25,000 sq. m. lot located at Bliss Site, Barangay Macabog, West District, Sorsogon City and was subdivided to its beneficiaries by way

of Memorandum of Agreement entered into by and between the beneficiaries and the Municipal Government of Sorsogon through the former Municipal Mayor Fernando O. Duran, Jr.;

**WHEREAS**, the forty (40) recipients are now in the process of titling their respective properties and has coordinated with pertinent authorities such as the Registry of Deeds;

**WHEREAS**, the Registry of Deeds required a resolution authorizing the incumbent Local Chief Executive to enter into a Contract of Sale with the beneficiaries of the said housing lot project;

**WHEREAS**, to assist the herein beneficiaries and to avoid further complications, the Local Chief Executive requested the 7<sup>th</sup> City Council for the passage of a resolution providing her with the authority to enter into a Contract of Sale with the beneficiaries of the said housing lot project;


