RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A LEASE CONTRACT WITH THE PHILIPPINE NATIONAL BANK (PNB) RELATIVE TO THE UTILIZATION OF A PARCEL OF LAND OWNED BY THE LATTER SITUATED AT DIVERSION ROAD, BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY AS STORAGE AREA FOR VEHICLES IMPOUNDED/CONFISCATED BY THE SORSOGON CITY PNP

WHEREAS, on March 23, 2021, the Office of the City Mayor sent a letter to the Philippine National Bank (PNB) requesting for permission to utilize latter's property latter situated at Diversion Road, Barangay Cabid-an, East District, Sorsogon City as storage area for vehicles impounded/confiscated by the Sorsogon City PNP;

WHEREAS, the Philippine National Bank (PNB), in reply thereto, informed the Office of the City Mayor that subject property is available for lease on a yearly basis, to which the Office of the City Mayor finds the same to be reasonable;

WHEREAS, the number of vehicles being impounded by the Sorsogon City PNP which are either confiscated or involved in road accident is inevitably increasing and is now in dire need for a space to store the said automobiles;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to authorize Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Lease Contract with the Philippine National Bank (PNB) relative to the utilization of a parcel of land owned by the latter situated at Diversion Road, Barangay Cabid-an, East District, Sorsogon City as storage area for vehicles impounded/confiscated by the Sorsogon City PNP.
