RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT DONATION OF A PARCEL OF LAND SITUATED AT BARANGAY GUINLAJON, WEST DISTRICT, SORSOGON CITY FROM THE HEIRS OF VICENTE L. PERALTA AND MERCEDES J. BERENGUER

WHEREAS, the Office of the City Mayor furnished the 7th City Council of the letter from the heirs of Vicente L. Peralta and Mercedes J. Berenguer, dated April 7, 2021, addressed to Hon. City Mayor Ma. Ester E. Hamor, expressing their intention to donate a parcel of land situated at Barangay Guinlajon, West District, Sorsogon City in favor of the city government;
