RESOLUTION ADOPTING CDRRMC RESOLUTION NO. 03-2021 APPROVING AND ADOPTING THE LIST OF PROJECTS UNDER THE LOCAL GOVERNMENT SUPPORT FUND – DISASTER REHABILITATION AND RECONSTRUCTION ASSISTANCE PROGRAM (LGSF-DRRAP) FOR FY 2021 AMOUNTING TO SIXTEEN MILLION ONE HUNDRED SIXTY-THREE THOUSAND ONE HUNDRED SIXTY-ONE PESOS (PHP 16,163,161.00)

WHEREAS, per Local Budget Circular No. 134, the Local Government Support Fund – Disaster Rehabilitation and Reconstruction Assistance Program (LGSF-DRRAP) shall be used to aid in the recovery and reconstruction of the economy and livelihood in the Local Government Units that are directly affected by Taal Volcano eruption, Typhoon Quinta, Super Typhoon Rolly and Typhoon Ulysses, as indicated in the situational reports issued by the National Disaster Risk Reduction and Management Council (NDRRMC);

WHEREAS, Typhoon Quinta, Rolly and Ulysses successively battered the city of Sorsogon during the last quarter of CY 2020 with damages estimated to be amounting to One Hundred Million Pesos (PHP 100M);

WHEREAS, following the guidelines set by the Department of Budget and Management (DBM) as to the implementation of said assistance, the City Disaster Risk Reduction and Management Council (CDRRMC) deliberated and approved the following projects to be funded under the downloaded LGSF-DRRAP, to wit:

- 1. Procurement of medicines and vitamins intended for 64 barangays with project allocation in the amount of P 6,000,000.00.
- 2. Rehabilitation of flood control structures and agricultural support facilities in the amount of P 10,163,161.00.

WHEREAS, this measure shall form part of the documentary requirements for the utilization of funds intended for the continuance of the programs, projects and activities of the city government of Sorsogon in connection with disaster management and response;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Joven G. Laura**, resolved as it is hereby resolve to adopt CDRRMC Resolution No. 03-2021 approving and adopting the list of projects under the Local Government Support Fund – Disaster Rehabilitation and Reconstruction Assistance Program (LGSF-DRRAP) for FY 2021 amounting to Sixteen Million One Hundred Sixty-Three Thousand One Hundred Sixty-One Pesos (PHP 16,163,161.00).
