RESOLUTION ADOPTING CDRRMC RESOLUTION NO. 04-2021 APPROVING AND ADOPTING THE LOCAL DISASTER RISK REDUCTION MANAGEMENT PLAN (LDRRMP) FOR SPECIAL TRUST FUND BALANCES FROM LDRRMP CYs 2020, 2018 AND 2017 AND ITS CORRESPONDING LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP)

WHEREAS, Section 6.4 of NDRRMC, DBM and DILG Joint Memorandum Circular No. 2013-1, dated 25 March 2013, states that “the unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities for the Local Disaster Risk Reduction Management Council (LDRRMC) for the next five (5) years”;

WHEREAS, Section 6.5 of the same JMC states that “the unexpended balances of the LDRRMF may be released and utilized for the new expenditure items upon submission of the revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP”;

WHEREAS, following the guidelines set under the same JMC, the City Disaster Risk Reduction and Management Office (CDRRMO) prepared the corresponding LDRRMP and LDRRMFIP for Special Trust Fund Balance from CYs 2020, 2018 and 2017 which was deliberated and approved by the LDRRMC;

WHEREAS, this measure shall form part of the documentary requirements for the utilization of funds intended for the continuance of the programs, projects and activities of the city government of Sorsogon in connection with disaster management and response;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Joven G. Laura**, resolved as it is hereby resolve to adopt CDRRMC Resolution No. 04-2021 approving and adopting the Local Disaster Risk Reduction Management Plan (LDRRMP) for special trust fund balances from LDRRMP CYs 2020, 2018 and 2017 and its corresponding Local Disaster Risk Reduction Management Fund Investment Plan (LDRRMFIP).
