RESOLUTION ADOPTING AND APPROVING THE CITY DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE RESOLUTION NO. 05, SERIES OF 2021 (RESOLUTION FAVORABLY APPROVING THE 2021 SUPPLEMENTAL ANNUAL INVESTMENT PLAN – 2 OF THE CITY GOVERNMENT OF SORSOGON AND INCLUSION OF THE SAME IN THE 2020-2025 CDP LDIP

WHEREAS, the City Government of Sorsogon, in compliance with RA 7160, otherwise known as the Local Government Code of 1991, particularly Section 106, sets to implement projects, programs and activities (PPAs) in the direction of economic and social development in the local government;

WHEREAS, various programs, projects and activities were determined to drive the socioeconomic development as identified by the different sectoral division, namely: General services, Social services, Economic Services and other services for the provision of an effective and efficient range of works, services and facilities that fulfill the needs and expectations of the community;

WHEREAS, these priority PPAs are meant to sustain responsiveness of government service by providing social and health services, enhancing infrastructure support facilities, facilitating agricultural productivity and pursing operational effectiveness and efficiency of the organization;

WHEREAS, as provided in the Joint Memorandum Circular No. 01-2007 and JMC No. 1-2016 of the DILG, NEDA, DBM and the DOF, as well as the Updated Budget Operations Manual (UBOM) of the DBM, LGUs are required or mandated to support all supplemental budgets with their corresponding AIPs;

WHEREAS, in compliance with the said Joint Memorandum Circular No. 01-2007 and JMC No. 1-2016 and of the Updated Budget Operations Manual (UBOM) the list of PPAs has been presented to the 7th City Council and the latter found the same to be in order in form and in substance and aligned with the city government's priorities and development strategies;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon Ma. Teresa D. Perdigon**, resolved as it is hereby resolve to adopt and approve the City Development Council-Executive Committee Resolution No. 05, Series of 2021 (Resolution favorably approving the 2021 Supplemental Annual Investment Plan – 2 of the City Government of Sorsogon and inclusion of the same in the 2020-2025 CDP LDIP.
