RESOLUTION APPROVING THE CANCELLATION OF TRICYCLE FRANCHISE NO. 3248 ISSUED TO THE LATE HENRY A. LAVADIA, SR. AND THEREBY AUTHORIZING HIS SON RICHARD D. LAVADIA TO SUBSTITUTE OR REPLACE HIS FATHER AND OPERATE TRICYCLE-FOR-HIRE IN THE CITY OF SORSOGON UNDER THE SAME FRANCHISE, MOTORCYCLE UNIT AND ROUTE OF OPERATION AS ALLOWED UNDER SECTION 13 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

WHEREAS, Mr. Henry A. Lavadia, Sr. of Barangay Ticol, West District, Sorsogon City, died on March 30, 2021, Death Certificate herewith attached and made integral part hereof;

WHEREAS, the late Henry A. Lavadia, Sr is the grantee of a Tricycle Franchise No. 3248/Tricycle Franchise Plate No. 3248 for Tricycle-for-Hire Service with the route Poblacion/SCTT to Guinlajon and Basud (GUINPABTODA), valid up to March 19, 2024 and with the following technical description, to wit:

WHEREAS, Section 13 of City Ordinance No. 22-2020 ("Sorsogon City New Tricycle Franchise Code of 2020") provides:

SECTION

VALIDITY OF FRANCHISE

Any franchise shall remain valid for a period three (3) years from the date of its issuance and shall be renewed on its anniversary date. If the anniversary date falls on a Saturday, Sunday or holiday or on the occasion of declared calamity the renewal shall be on the next working day immediately after.

The inaction of the grantee for a period of six (6) months after the expiration of tricycle franchise shall cause an automatic revocation of the privilege granted after 2 (two) notices.

Within six (6) months from the death of the franchise holder, the Certificate of Franchise shall be surrendered to the Sangguniang Panlungsod through CTFRO. The surviving spouse or any of his/her children shall be the priority applicant for the said recalled franchise. Failure to report and surrender the said franchise within the prescribed period shall be forfeited in favor of the city government and may be awarded to qualified waiting applicant.

WHEREAS, Richard D. Lavadia, son of the deceased, resident of Barangay Ticol, West District, Sorsogon City, applied to substitute or replace his father in conformity with the provisions here above stated;

WHEREAS, the 7th City Council finds the application of Richard D. Lavadia to be meritorious and he is qualified to substitute or replace his father to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Erwin J. Duana**, resolved as it is hereby resolve to approve the cancellation of Tricycle Franchise No. 3248 issued to the late Henry A. Lavadia, Sr. and thereby authorizing his son Richard D. Lavadia to substitute or replace his father and operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".
