RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO FACILITATE THE INSPECTION, APPRAISAL AND POSSIBLE CONDEMNATION AND DEMOLITION OF THE RURAL HEALTH UNIT (RHU) AT POBLACION, BACON DISTRICT, SORSOGON CITY

WHEREAS, the Office of the City Mayor has informed the 7th City Council with their intent to facilitate the demolition of the rural health unit (RHU) at Poblacion, Bacon District, Sorsogon City which shall pave the way for the construction of a new building thereat;

WHEREAS, the new edifice shall serve as an improved Rural Health facility that shall cater to the well-being of the residents of the twenty eight barangays of Bacon District, Sorsogon City which shall contribute to the program and development of the area;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for

its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitant;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to facilitate the inspection, appraisal and possible condemnation and demolition of the rural health unit (RHU) at Poblacion, Bacon District, Sorsogom City.
