RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF THE PRESIDENT REPRESENTED BY SALVADOR C. MEDIALDEA RELATIVE TO THE GRANT AMOUNTING TO FIVE MILLION PESOS (P5,000,000.00)

WHEREAS, in light with the continuing battle of the City Government of Sorsogon against Covid 19 pandemic, the Office of the City Mayor sought the assistance of the Office of the President through her letter dated February 22, 2021 requesting for support, in cash or in kind, intended to respond the challenges brought about by the massive in-migration in the City of Sorsogon;

WHEREAS, these new migrants seek refuge the comfort of their hometown and families after being displaced in Metro Manila and other parts of the country;

WHEREAS, the increasing population by in-migration caused an upsurge in local demands and because of limited resources, the city government found it difficult to cope with;

WHEREAS, the City Government of Sorsogon is fortunate for the Office of the President finds its request eligible for an assistance amounting to Five Million Pesos (Php 5,000,000.00) intended to respond to the immediate needs of those severely affected by the pandemic;

NOW THEREFORE, on motion of **Hon. Joven G. Laura** duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Office of the President represented by Salvador C. Medialdea relative to the grant amounting to Five Million Pesos (P 5,000,000.00).
