EQUIPMENT TO CAPITAL OUTLAY, FURNITURES AND FIXTURES OF THE CITY GENERAL SERVICES OFFICE IN THE AMOUNT OF FIVE HUNDRED THOUSAND (P500,000.00) PESOS AND FROM MAINTENANCE & OTHER OPERATING EXPENSES OTHER GENERAL SERVICES TO MAINTENANCE AND OTHER OPERATING EXPENSES INTERNET EXPENSE OF THE CITY BUDGET OFFICE IN THE AMOUNT OF SIX THOUSAND (P6,000.00) PESOS

WHEREAS, Section 336 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the Local Chief Executive or the Presiding Officer of the Sanggunian concerned may by an ordinance authorize the augmentation of any item in the approved annual

budget for offices from savings in other items within the same expense class of their respective appropriations;

WHEREAS, in order to pursue the mandate given to the said office specifically the need to address social and legislative services, sufficient funds for the purpose is indispensable;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to approve the same;

NOW THEREFORE, on motion of **City Councilor Nestor J. Baldon**, duly seconded by the **City Councilor Danilo A. Deladia**, the 7th City Council hereby approves and augments the funds for the hereunder Source of Fund and Destination of Fund for the herein mentioned office.
