RESOLUTION APPROVING THE INCREASE OF FINANCIAL ASSISTANCE FOR BARANGAY TANOD IN THE CITY OF SORSOGON FROM P400.00 TO P500.00 IN RESPONSE TO THE MANIFESTO ISSUED BY THE LIGA NG MGA BARANGAY- SORSOGON CITY CHAPTER AND SANGGUNIANG PANLUNGSOD RESOLUTION NO. 267, SERIES OF 2020

WHEREAS, on March 8, 2020, the Office of the President issued Proclamation No. 922 declaring a state of Public Health Emergency throughout the Philippines due to COVID 119 and thereafter placing the whole island of Luzon under the Enhance Community Quarantine (ECQ) subsequently the Province of Sorsogon had been placed to General Community Quarantine (GCQ) and to Modified General Community Quarantine (MGCQ);

WHEREAS, In compliance with the guidelines and minimum health standards imposed by the national Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases, the barangay officials, with the undeniable participation of our barangay tanods, conducted an intensified monitoring, established boundary check points, enforced curfew hours and all other similar undertakings;

WHEREAS, the Manifesto of the Liga ng mga Barangay recognized the heroic participation of Barangay Tanod to combat COVID 19 in their respective barangay;

WHEREAS, the Manifesto was issued for the increase of the monthly financial aid to Barangay Tanods by the City Government to Five Hundred (P500.00) Pesos in the preparation of the Annual Budget for CY 2021;

WHEREAS, the Sangguniang Panlungsod through and by Resolution No. 267, Series of 2020 extended its support to the Manifesto of the Liga ng mga Barangay- Sorsogon City Chapter for the increase of financial assistance for Barangay Tanod;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Franco Eric O. Ravanilla**, resolved as it is hereby resolve to approve the increase of financial assistance for Barangay Tanod in the city of Sorsogon from P400.00 to P500.00 in response to the manifesto issued by the Liga ng mga Barangay- Sorsogon City Chapter and Sangguniang Panlungsod Resolution No. 267, Series of 2020;
