RESOLUTION APPROVING THE CANCELLATION OF THE HEREIN TRICYCLE FRANCHISES AND THEREBY AUTHORIZING PRIORITY APPLICANTS TO SUBSTITUTE OR REPLACE THE FORMER TO OPERATE TRICYCLE-FOR-HIRE IN THE CITY OF SORSOGON UNDER THE SAME FRANCHISE, MOTORCYCLE UNIT AND ROUTE OF OPERATION AS ALLOWED UNDER SECTION 13 OF CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

WHEREAS, the following were applied for dropping/cancellation of Tricycle Franchise due to the demise of the holders thereof with their respective Death Certificate attached and made

integral part hereof, to wit:

1. **MICHAEL CALANASAN** of Barangay Poblacion, Bacon District, Sorsogon City, died on February 15, 2021, a grantee of a Tricycle Franchise No. 2915/Tricycle Franchise Plate No. 2915 for Tricycle-for-Hire Service with the route Bacon Public Market to Rawis. Del Rosario, Sto. Domingo, San Juan-Barrio Site and Lebanon, Buhawi, Tiris and Look (Gajo) and Sta. Cruz (PJBTODA), valid up to August 8, 2024 and with the following technical description, to wit:

2. **JOSE N. ASEJO** of Barangay San Juan, Bacon District, Sorsogon City, died on February 15, 2021, a grantee of a Tricycle Franchise No. 2913/Tricycle Franchise Plate No. 2913 for Tricycle-for-Hire Service with the route Bacon Public Market to Rawis. Del Rosario, Sto. Domingo, San Juan-Barrio Site and Lebanon, Buhawi, Tiris and Look (Gajo) and Sta. Cruz (PJBTODA), valid up to September 6, 2020 and with the following technical description, to wit:

WHEREAS, Section 13 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides:

SECTION 13 VALIDITY OF FRANCHISE

Any franchise shall remain valid for a period three (3) years from the date of its issuance and shall be renewed on its anniversary date. If the anniversary date falls on a Saturday, Sunday or holiday or on the occasion of declared calamity the renewal shall be on the next working day immediately after.

The inaction of the grantee for a period of six (6) months after the expiration of tricycle franchise shall cause an automatic revocation of the privilege granted after 2 (two) notices.

Within six (6) months from the death of the franchise holder, the Certificate of Franchise shall be surrendered to the Sangguniang Panlungsod through CTFRO. The surviving spouse or any of his/her children shall be the priority applicant for the said recalled franchise. Failure to report and surrender the said franchise within the prescribed period shall be forfeited in favor of the city government and may be awarded to qualified waiting applicant.

WHEREAS, LILIBETH I. CALANASAN, resident of Barangay Poblacion, Bacon District, Sorsogon City, surviving spouse of the deceased Michael D. Calanasan and **CARLA MARIE A. DON**, resident of Barangay San Juan, Bacon District, Sorsogon City, daughter of the deceased Jose N. Asejo, applied to respectively substitute or replace their deceased family member in conformity with the provisions here above stated;

WHEREAS, the 7th City Council finds the herein applications to be meritorious and they are qualified to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Ma. Teresa D. Perdigon**, resolved as it is hereby resolve to approve the cancellation of the herein tricycle franchises and thereby authorizing priority applicants to substitute or replace the former to operate Tricycle-for-Hire in the City of Sorsogon under the same franchise, motorcycle unit and route of operation as allowed under Section 13 of City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020".
