RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A CONTRACT TO SELL AND PURCHASE BY WAY OF ABSOLUTE SALE FOR A PARCEL OF LAND CONSISTING AN AREA OF TWENTY NINE THOUSAND ONE HUNDRED SEVENTEEN (29,117) SQUARE METERS SITUATED AT BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated April 26, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and to the honorable members of the 7th City Council, requested to pass a resolution authorizing her to enter into a Contract to Sell and Purchase by way of Absolute Sale for a parcel of land consisting an area of Twenty Nine

Thousand One Hundred Seventeen (29,117) Square Meters situated at Barangay Bibincahan, East District, Sorsogon City;

WHEREAS, the subject property covered by Transfer Certificate of Title No. 083-2018000930 and registered in the name of Niki Monina Aramburo – Reveche shall be purchased by the City Government of Sorsogon in the amount of Two Million Five Hundred Thousand Pesos (Php 2,500,000.00) chargeable against local funds;

WHEREAS, after the transfer of ownership of the aforesaid property, the same shall be used in the implementation of programs and projects of the City Government which are beneficial to the community and shall form part of the total development of the City of Sorsogon;

NOW THEREFORE, on motion of **Hon. Erwin J. Duana** duly seconded by **Hon. Ma. Teresa D. Perdigon**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Contract to Sell and Purchase by way of Absolute Sale for a parcel of land consisting an area of Twenty Nine Thousand One Hundred Seventeen (29,117) Square Meters situated at Barangay Bibincahan, East District, Sorsogon City.
