RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ACCEPT THE DONATION OF A ROAD RIGHT OF WAY CONSISTING OF A FOUR HUNDRED NINE (409) SQUARE METERS LOCATED AT SITIO SIP-AC, BARANGAY CABID-AN, EAST DISTRICT, SORSOGON CITY

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated April 29, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor and to the honorable members of the 7th City Council, requested to pass a resolution authorizing her to accept the donation of a Road Right of Way consisting an area of Four Hundred Nine (409) Square Meters located at Sitio Sip-ac, Barangay Cabid-an, East District, Sorsogon City;

WHEREAS, the Road Right of Way consisting an area of Four Hundred Nine (409) Square Meters located at Sitio Sip-ac, Barangay Cabid-an, East District, Sorsogon City is donated by Mr. Ramon L. Gabito and Elmer Y. Gemperoso is covered by TCT No. 083-2021000021, ARP No. 1999-14-013-1619, PIN 032-14-013-17-629-MO and the land taxes are duly paid up to 2021;

WHEREAS, the said parcel of land is actually a road intended for use by the owner/possessors of the adjoining properties with a memorandum encumbrance under its Title that say it cannot be closed or disposed except by way of donation to the national government, province, city or municipality;
