RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER INTO A SERVICE AGREEMENT WITH THE SMART COMMUNICATIONS, INC. RELATIVE TO THE SMART WI-FI SERVICES

WHEREAS, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City on its letter dated April 29, 2021, addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City and to the honorable members of the 7th City Council, requested to pass a resolution authorizing her to enter into a Service Agreement with the Smart Communications, Inc. relative to the Smart Wi-Fi Services;

WHEREAS, Smart Communications Inc. a telecommunication company offered their Smart Wi-Fi services to the city government intended for the provision of internet access to various areas with the city of sorsogon, for free;

WHEREAS, the city government have chosen the following areas for the installation of the Smart Wi-Fi Services, to wit:

1. Two (2) units at the Rompeolas, Talisay, West District
2. One (1) unit at the Bacon Municipal Hall, Poblacion, Bacon District
3. One (1) unit at the Bacon Public Market
4. One (1) unit at the Sorsogon City Public Market

WHEREAS, the Wi-Fi access shall pave the way for easier communication and provide access to a wider range of networks not only for the occupants of the edifices but for the clients therein as well;


NOW THEREFORE, on motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Fernando David H. Duran, III**, resolved as it is hereby resolve to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Service Agreement with the Smart Communications, Inc. relative to the Smart Wi-Fi Services.
