RESOLUTION RESPECTFULLY REQUESTING MR. WILBERT T. LEE OF LKY GROUP OF COMPANIES TO VACATE AND OFFICIALLY TURN OVER THE POSSESSION OF THE LKY BUILDING/ARCADE LOCATED AT MARKET SITE, BARANGAY SIRANGAN, EAST DISTRICT ON AUGUST 1, 2021 IN FAVOR OF THE CITY GOVERNMENT OF SORSOGON

WHEREAS, in response to the letter of the late Atty. Roberto. T. Labitag, former City Legal Officer of the City Government of Sorsogon, LKY Group of Companies through Mr. Wilbert T. Lee replied that the Lease Contract over the LKY Building/Arcade located at the Market Site, Barangay Sirangan, East District, Sorsogon City is for a period of 25 years beginning August 1996;

WHEREAS, the right to possess and enjoy the property by the LKY under the said Lease Contract will end on July 31, 2021;

WHEREAS, having been declared as such, it is most respectfully requested that LKY should vacate and officially turn over the possession of the LKY Building/Arcade located at the Market Site, Barangay Sirangan, East District on August 1, 2021 in favor of the City Government of Sorsogon;

WHEREAS, in consonance thereto, it is likewise requested that LKY shall advise and instruct its tenants to renew their respective rent/lease contract and pay their rentals with the city government of Sorsogon starting August 1, 2021;

NOW THEREFORE, on motion of **Hon. Franco Eric O. Ravanilla** duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to respectfully request Mr. Wilbert T. Lee of LKY group of companies to vacate and officially turn over the possession of the LKY Building/Arcade located at the Market Site, Barangay Sirangan, East District on August 1, 2021 in favor of the City Government of Sorsogon.
