RESOLUTION AUTHORIZING THE BARANGAYS WITH HIGHER NUMBERS OF APPREHENDED/RECORDED VIOLATORS OF THE MINIMUM HEALTH AND SAFETY PROTOCOLS TO REACTIVATE AND INTENSIFY COVID 19 MONITORING STATION WITHIN THEIR RESPECTIVE BARANGAY TO STRICTLY IMPLEMENT ALL LAWS, ORDINANCES AND ISSUANCES RELATIVE THERETO

WHEREAS, placing the Province of Sorsogon to Modified General Community Quarantine (MGCQ), some security protocols such as barangay checkpoints/monitoring stations were abolished, relaxed or loosen;

WHEREAS, considering the recent development or the increasing numbers of Covid 19 positives and placing the City of Sorsogon to a high risk category, there is a need to reactivate monitoring stations in the barangays as an effective monitoring system specially to those with most recorded violators;

WHEREAS, the reactivation of barangay monitoring stations could somehow relieve worries of every human mind in the city jurisdiction from the sudden and drastic increase of Covid cases in the communities;

WHEREAS, records revealed that Barangays of Bibincahan, Balogo (East), Sampaloc, Pangpang, Guinlajon, Talisay, Cambulaga, Sirangan, Buhatan, Cabid-an and Bitan-o have the most recorded numbers of violation of the minimum health protocols as per Report of Sorsogon City Anti-Covid 19 Task force covering operations from April 16, 2021 to April 28, 2021;

WHEREAS, Section 8 of City Ordinance No. 13, Series of 2021, otherwise known as the "Sorsogon City Emergency Curfew Ordinance of 2021 AMID COVID 19" and under Section 4 of City Ordinance No. 14, Series of 2021, otherwise known as the "Mandatory wearing of face mask, face shields and observance of Social/Physical Distancing Ordinance of 2021", barangay officials and their barangay tanods along with the PNP-Sorsogon City and TMECS/SK3/Public Order and Safety Office, through the issuance of City Ordinance Violation Citation Tickets are mandated to implement the provisions thereunder;

WHEREAS, other barangays are also encouraged to reactivate their respective monitoring station for the same undertakings;

NOW THEREFORE, on motion of **Hon. Ma. Teresa D. Perdigon** duly seconded by **Hon. Nestor J. Baldon**, resolved as it is hereby resolve to authorize the barangays with higher numbers of apprehended/recorded violators of the minimum health and safety protocols to reactivate and intensify Covid 19 monitoring station within their respective barangay to strictly implement all laws, ordinances and issuances relative thereto.
