## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 10th day of September , 2020 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JUDITH M. DOLLISON proprietor of WRITESHOP ENTERPRISES (hereinafter called the "Supplier") of the other part:
