- 1. The City Government of Sorsogon, through the 20% City Dev't Fund intends to apply the sum of Four Million Six Hundred Ninety Thousand Three Hundred Sixty Six & 30/100 Pesos (Php 4,690,366.30) Only being the Approved Budget for the Contract (ABC) to payments under the contract for **REHABILITATION/IMPROVEMENT OF MARKET STALL** under Project Reference No. CW 2021-11-046. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Sorsogon now invites bids for the above Procurement Project. Completion of the Works is required with in 90 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from 9:00A.M to 3:00 PM Only.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *November 9, 2021* from given address and website/s <u>sorsogoncity.gov.ph</u> and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand (P5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The *City Government of Sorsogon* will hold a Pre-Bid Conference<sup>1</sup> on *November 17*, 2021 @ 9:00am at *BAC Office*, *City Hall, Cabid-an, East District, Sorsogon City* which shall be open to prospective bidders however SHALL observed the Provincial Government Guidelines on COVID19 precautionary measures issued under EO No. 22 in relation to IATF protocol.
- 7. Bids must be duly received by the BAC Secretariat on December 1, 2021 at 8:00 A.M through the authorized representative of the bidder who is also responsible in the observance of the health protocol . Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
