

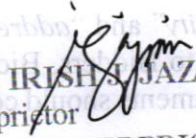

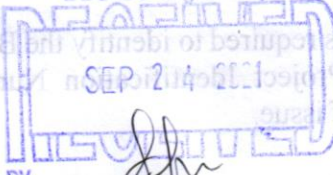

### CONTRACT AGREEMENT

THIS AGREEMENT made this **17th** day of **September**, **2021** between **Ma. Ester E.
