CONTRACT AGREEMENT

THIS AGREEMENT made this 15th day of October , 2021 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JAYRO J. LABASBAS Proprietor JAYRO CONSTRUCTION & SUPPLY (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF MATERIALS FOR THE CONST. OF LOCAL ROAD** @ SITIO MALABOG, SN PASCUAL and has accepted a Bid by the Supplier for the supply of those goods and services in the sum *Four Hundred Nineteen Thousand Six Hundred Twelve Pesos (Php 419,612.00) Only* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections (*corrections*) (bidder's bid evaluation; so the bid, if any, resulting from the Procuring Entity's bid evaluation; so CIT)

iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and TE:.
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of *Four Hundred Nineteen Thousand Six Hundred Twelve Pesos (Php 419,612.00) Only* or such other sums as may be ascertained, *JAYRO CONSTRUCTION & SUPPLY* agrees to viz *PROCUREMENT OF MATERIALS FOR THE CONST. OF LOCAL ROAD @ SITIO MALABOG, SN PASCUAL* in accordance with his/her/its Bid.
