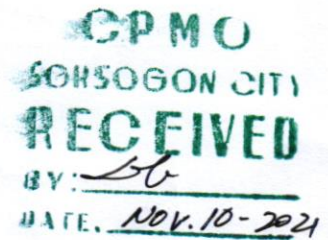
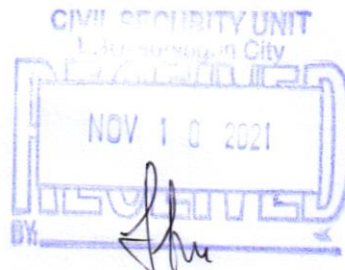

CONTRACT AGREEMENT

Contract No. 244-2021-S

THIS AGREEMENT made this **8th** day of **November**, **2021** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **MARIA LINDEL PENALES MANZANO** Proprietor of **ALMONIX MEDICAL EQUIPMENT AND SUPPLIES TRADING** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF A3 VELLUM BOARD (200GSM) WHITE FOR THE EBHIDA OF SELFIE PROGRAM** during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Three Hundred Thousand (Php 300,000.00) Pesos** (hereinafter called "the Contract Price").

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

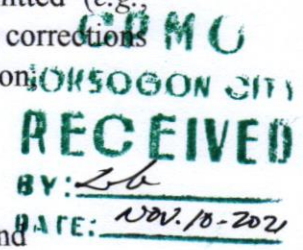
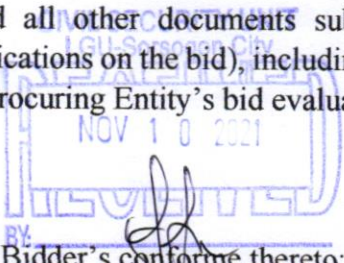
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conformé thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Three Hundred Thousand (Php 300,000.00) Pesos** or such other sums as may be ascertained, **ALMONIX MEDICAL EQUIPMENT AND SUPPLIES TRADING** agrees to viz **PROCUREMENT OF A3 VELLUM BOARD (200GSM) WHITE FOR THE EBHIDA OF SELFIE PROGRAM** in accordance with his/her/its Bid.


