Contract Agreement No. B- 2021-023-GS

THIS AGREEMENT made this **5th** day of **November**, **2021** between **Ma. Ester E. Hamor**, **City Mayor**, **City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **MS. MILAGROS D. LIAO** Proprietor of **BIG B ENTERPRISES** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF BASIC NECESSITIES FOR THE SUPPLEMENTAL FEEDING PROGRAM** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Six Million Four Hundred Thirty One Thousand Nine Hundred Eight & 05/100 Pesos (P 6,431,908.05) Only (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of <u>Six Million Four Hundred Thirty One Thousand</u> <u>Nine Hundred Eight & 05/100 Pesos (P 6,431,908.05) Only</u> or such other sums as may be ascertained, BIG B ENTERPRISES agrees to <u>PROCUREMENT</u> OF BASIC NECESSITIES FOR THE SUPPLEMENTAL FEEDING PROGRAM_ in accordance with his/her/its Bid.
