### EXECUTIVE ORDER NO. 13, SERIES of 2021

#### AN ORDER RECONSTITUTING THE SORSOGON CITY AWARDS COMMITTEE (SCAC) RELATIVE TO THE LUPONG TAGAPAMAYAPA INCENTIVES AND AWARDS (LTIA) ASSESSMENT

WHEREAS, *Katarungang Pambarangay* was created under Presidential Decree No. 1508 to formally organize into a system the time-honoured Filipino tradition of amicably settling interpersonal disputes in the barangay without judicial recourse;

WHEREAS, Executive Order 394, Series of 1997 was issued establishing the *Lupong Tagapamayapa* Incentives and Awards in recognition of the *Lupon* contribution in promoting the *Katarungang Pambarangay* objectives;

WHEREAS, Section 399 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991" mandates the creation of *Lupong Tagapamayapa* in every barangay, a system to mediate, conciliate and/or arbitrate disputes in the barangays to promote speedy administration of justice;

WHEREAS, Section 406 (b) of RA 7160 mandates the Department of the Interior and Local Government (DILG) to provide for a system of granting economic or other incentives to the *Lupon* or *Pangkat* members who adequately demonstrate the ability to judiciously and expeditiously resolve cases referred to them;

WHEREAS, DILG MC Nos. 2008-162 and 2016-58 were issued providing for the criteria and guidelines in the conduct of assessment of *Lupong Tagapamayapa* Incentives and Awards (LTIA), while an Unnumbered Memorandum dated February 2, 2021 was issued stating the Guidelines on the CY 2021 *Lupong Tagapamaya* Incentives Awards (LTIA) Implementation and Providing a Standard Documentation Report for LTIA 2021 National Entries;

NOW, THEREFORE, I MA. ESTER E. HAMOR, Mayor of the City of Sorsogon, by virtue of the powers vested in me by law, do hereby order reconstitution of the Sorsogon City Awards Committee (SCAC) relative to the *Lupong Tagapamayapa* Incentives and Awards (LTIA) Assessment, as follows:

Section 1. *Creation and Composition of the Sorsogon City Awards Committee (SCAC)*. The SCAC shall be composed of the following:

**Section 2. *Duties and Functions.***

- a. Initiate and coordinate the necessary activities toward the successful implementation of the LTIA in the municipality;
- b. Disseminate information on the Awards and generate awareness and support from the private and the public sectors within the Municipality;
- c. Select and submit to the Provincial Awards Committee the best performing Lupon in the Municipality;
- d. May secure funding and counterpart prizes from the partner agencies and the private sector; and
- e. May plan and implement appropriate awarding ceremonies.

**Section 3. *Repealing Clause.*** Any Executive Orders or Administrative Orders previously issued which are inconsistent herewith are hereby repealed, amended and/or modified accordingly.

**Section 4. *Effectivity.*** This Executive Order shall take effect immediately upon its issuance as stated hereunder.
