

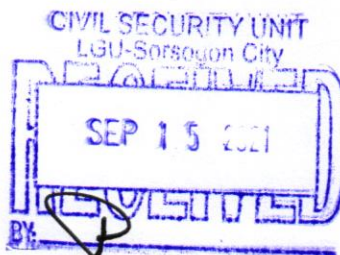

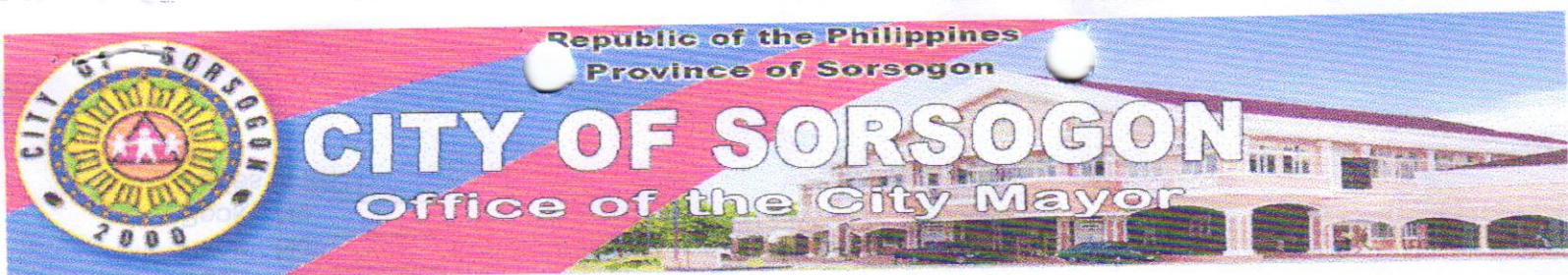

CONTRACT AGREEMENT

THIS AGREEMENT made this **3rd** day of **September**, **2021** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **ENGR. RAQUEL G. ESPEDIDO** Proprietor of **RMH CONSTRUCTION & SUPPLY** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **RELOCATION OF PRIMARY POLE OF SORECO II AT SAN ROQUE BARANGAY HALL** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **One Hundred Eight Thousand Eight Hundred Fourteen & 43/100 Pesos (P 108,814.43)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid form, resulting from the Procuring Entity's bid evaluation;

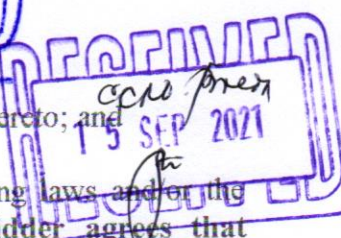
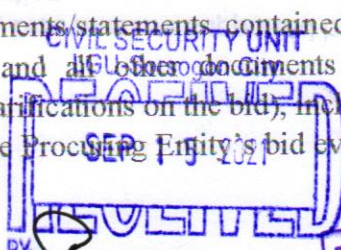
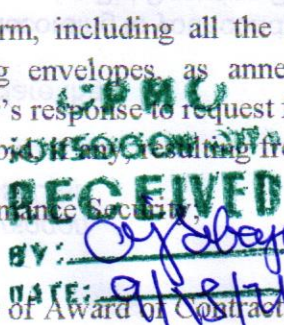
- iii. Performance Security;
- iv. Notice of Award of Contract, and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Hundred Eight Thousand Eight Hundred Fourteen & 43/100 Pesos (P 108,814.43)** or such other sums as may be ascertained, **RMH CONSTRUCTION & SUPPLY** agrees to viz **RELOCATION OF PRIMARY POLE OF SORECO II AT SAN ROQUE BARANGAY HALL** in accordance with his/her/its Bid.

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


