



CONTRACT AGREEMENT

THIS AGREEMENT made this **15th** day of **October**, 2021 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity ”) of the one part and **ASHLEY P.
