CONTRACT AGREEMENT

THIS AGREEMENT made this 12th day of November , 2021 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOEFFREY A. PERALTA Branch Manager of K-SERVICO TRADE, INC. (hereinafter called the "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>

In consideration for the sum of One Hundred Fifty Seven Thousand Pesos (P 157,000.00) or such other sums as may be ascertained, K-SERVICO TRADE, INC. agrees to viz **PROCUREMENT** OF 1-UNIT SCOOTER TYPE MOTORCYCLE FOR BAC OFFICE USE in accordance, with histher/its Bid.
