CONTRACT AGREEMENT

THIS AGREEMENT made this **10th** day of **December**, **2021** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **SHEREEN V. FRANCISCO** proprietor of **D & Y ENTERPRISES** (hereinafter called the "Supplier") of the other part:

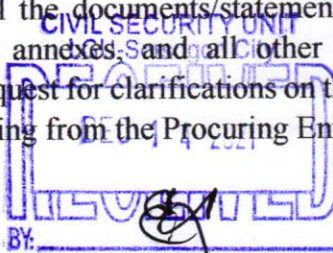
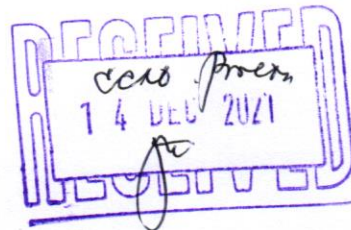
- iii. Performance Security;

CONTRACT AGREEMENT

THIS AGREEMENT made this **31st** day of **August**, **2021** between **Ma. Ester E.
