

CONTRACT AGREEMENT

THIS AGREEMENT made this **10th** day of **December**, 2020 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity ") of the one part and **JOSE BONIFACIO L. LASALA** proprietor of **JL ENTERPRISES** (hereinafter called the " Supplier ") of the other part:


