

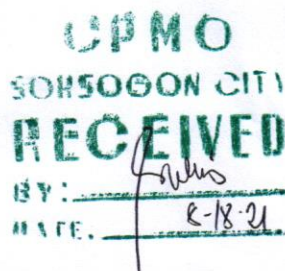
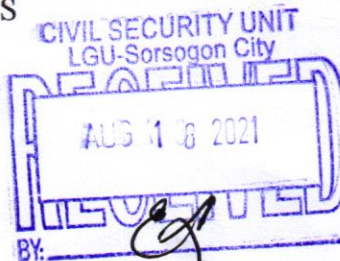

CONTRACT AGREEMENT

THIS AGREEMENT made this **13th** day of **August**, **2021** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and **AMIEL S. ENCELA** proprietor of **A.E OFFICE AND SCHOOL SUPPLIES** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF WORKING UNIFORM FOR THE GAYON SORSOGON WORKERS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Four Hundred Fifty Two Thousand Eight Hundred Pesos (P 452,800.00)** (hereinafter called "the Contract Price").

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

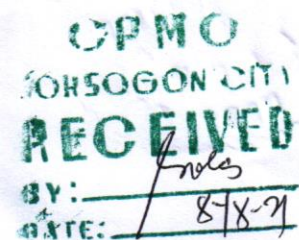
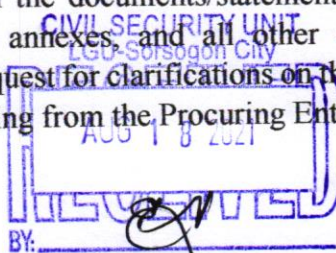
- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Four Hundred Fifty Two Thousand Eight Hundred Pesos (P 452,800.00)** or such other sums as may be ascertained, **A.E OFFICE AND SCHOOL SUPPLIES** agrees to **PROCUREMENT OF WORKING UNIFORM FOR THE GAYON SORSOGON WORKERS** in accordance with his/her/its Bid.

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


