## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 4th day of October , 2020 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and RICHARD L. LOSANTAS Authorized Representative of PHILCOPY CORPORATION (hereinafter called the "Supplier") of the other part:
