CONTRACT AGREEMENT

THIS AGREEMENT made this 4th day of February , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and AGNES TAN Authorized Representative of JEANEE'S SUPERMART & DEPARTMENT STORE, INC. (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF VARIOUS GENERAL MDSE FOR THE FOOD ASSISTANCE TO SENIOR CITIZEN** during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Six Hundred Eighty Three Thousand Nine Hundred Thirty Five Pesos** (**P 683,935.00**) **Only** during the State of Health Emergency (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract execution,</u> <u>such as the Notice to Proceed, Variation Orders, and Warranty Security,</u> <u>shall likewise form part of the Contract.</u>

In consideration for the sum of Six Hundred Eighty Three Thousand Nine Hundred Thirty Five Pesos (P 683,935.00) Only or such other sums as may be ascertained, JEANEE'S SUPERMART & DEPARTMENT STORE, INC. agrees to viz PROCUREMENT OF VARIOUS GENERAL MDSE FOR THE FOOD ASSISTANCE TO SENIOR CITIZEN in accordance with his/her/its Bid.
