



Contract Agreement No. B- 2021-011-GS

THIS AGREEMENT made this **9th** day of **July**, 2020 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **MS. ERLENA D. BENZON** Proprietor of **ERL PHARMA** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROCUREMENT OF MEDICINE TO MANAGE EFFECT ON HEALTH AFTER CALAMITY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million One Hundred Ninety One Thousand Seven Hundred Fifty Six & 80/100 (P 3,191,756.80) Only** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of Three Million One Hundred Ninety One Thousand Seven Hundred Fifty Six & 80/100 (P 3,191,756.80) Only or such other sums as may be ascertained, **ERL PHARMA** agrees to PROCUREMENT OF MEDICINE TO MANAGE EFFECT ON HEALTH AFTER CALAMITY in accordance with his/her/its Bid.




