## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 12th day of November , 2021 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the "Entity" ) of the one part and Authorized Partner of WRITESHOP ENTERPRISES JUDITH M. DOLLISON hereinafter called the "Supplier" ) of the other part:
