CONTRACT AGREEMENT

THIS AGREEMENT made this 10th day of December , 2021 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JENNY L. BARSHOP Proprietor of BEAT BOX TAVERN (hereinafter called the "Supplier") of the other part:


