



## CONTRACT AGREEMENT

THIS AGREEMENT made this **3rd** day of **January**, **2022** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and **MA. CRISTINA E. DURAN** Proprietor **PAOPAO HOTEL AND RESIDENCES** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz (EARLY PROC.
